Dear Sir,

The undersigned is directed to inform you that on receipt of the recognition letter from N.C.T.E. (vide No. ERC/7-87.6(II).19/2008/12678 dated 20.08.2008), the Executive Council of the Vidyasagar University in its meeting dated 09.09.2008 considered the Inspection Report submitted by the duly constituted Inspection Team and granted temporary affiliation to B.Ed. Course of Kadambini Women's College of Education which will run the course from the academic session 2008-2009 subject to the fulfillment of the following terms & conditions :

The terms & conditions of affiliation of the above course :

01. The intake capacity at the initial stage for the above mentioned course is 100.
02. Students will be admitted purely on merit basis and the admission be made by the University centrally through counselling.
03. At least 1 (one) whole-time qualified teacher in each subject of English & Mathematics are to be appointed immediately on receipt of the affiliation letter. Joining letters to be submitted to the University within 15 days alongwith a declaration that they are not engaged in any other institution.
04. Part-time teachers as and when required may also be appointed.
05. The Governing Body will have to be formed within one year of affiliation as per Vidyasagar University Statutes, 1983.
06. The college must abide by the Vidyasagar University Act, Statutes, Ordinances, Regulations etc. as amended from time to time.
07. The college must built up a Reserved Fund of Rs.20,00,000/- (Rupees twenty lakhs) only within one year.
08. Books in adequate number for different subjects as per syllabus are to be procured by the college.
09. The following method subjects has been granted to Kadambini Women's College of Education for the session 2008-2009 :
(a) Bengali, (b) English, (c) History and (d) Mathematics.

10. Play Ground and facilities for outdoor and indoor games to be developed at the earliest.
11. Facilities for cultural activities to be created and maintained by the college.
12. Rs.1,000/= (Rupees one thousand only) per student per annum to be deposited by the college to the affiliating University.
13. Well furnished and fully equipped Laboratories for Physical Science, Life-Science, Geography etc. are to be set up within three months from the date of granting affiliation.
14. Separate class rooms for method subjects are to be provided.
15. Common Room will have to be provided for the students.
16. The affiliation of the University shall remain valid so long as the college enjoys the recognition of the N.C.T.E.
17. The college will have to submit a compliance report to the University after fulfilling the above conditions on receipt of which formal affiliation will be extended.

An early reply accepting the terms and conditions of granting affiliation of the above mentioned course at the Kadambini Women's College of Education should reach the undersigned with a copy to the Inspector of Colleges.

Programme at your Institution under The West Bengal University of Teachers` Training, Education Planning and Administration w.e.f. the academic session 2017-2018 subject to the renewal of affiliation every year and fulfillment of the following terms and conditions:

1. The college shall be guided by the NCTE Regulations 2014 in respect of appointment of teaching and non-teaching staff, purchase of books, audio-visual material and automation of the library.
2. The college will continue to organize and equip the laboratories as per stipulation of NCTE. Other infrastructure are to be maintained as per NCTE norms.
3. The said college shall be obliged to follow the fee structure and other terms and conditions specified by the State Government /Competent Authority under NCTE regulations from time to time. Appropriate action shall be taken if any irregularities are found in this regard.
4. Intake capacity will be as per NCTE norms.
5. Appointment of faculty already done/ to be done in future and their pay and allowances must follow the latest NCTE, UGC and State govt. norms. It is advised to make payment to the staff of the college through A/C payee cheque drawn on a (preferably) Nationalized Bank. Stern action shall be taken if any irregularities are found in this regard.

In respect of maintenance of academic and financial discipline the college will strictly follow norms of NCTE (in strict observance of the latest notification)/State Government Orders issued from time to time and relevant conditions/rules of the Affiliating University in this regard especially with respect to the minimum number of teaching days in an academic session as stipulated by the Affiliating University/NCTE.
7. Expert(s), duly authorized by the University may make 'surprise visit' to the college for rapid, on-spot assessment of the quality of functioning. If any short-fall / discrepancy is identified by the Inspection Team, affiliation of the programme may be withdrawn.
8. The college authority shall abide by the Acts, Statutes, Regulations etc. of this University as are in force or as may be amended from time to time.
9. Admission of students will be as per norms stipulated by the University.
10. Staying in the college hostel, if any, is not mandatory for the students.
11. The Governing Body of the College is to be constituted as per provisions of the State Govt. / Affiliating University.
12. The following school subjects are approved as Pedagogy subjects for curriculum transaction at your college along with other foundation courses and optional courses, if any :
Bengali, English, Geography, History, Life Science, Mathematics, Physical Science, Sanskrit, Music.
